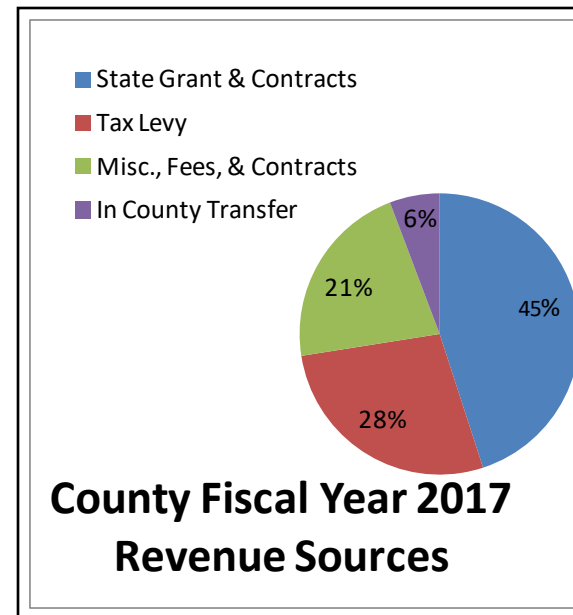

## Women, Infants and Children (WIC) Supplemental Food Program

The Moultrie County Health Department WIC program is a supplemental nutrition program which serves to enhance the health and well-being of pregnant women, infants and children through the age of five years.. The WIC program provides nutrition education, breast-feeding support, and food instruments to enrolled clients. The Moultrie County Health Department also provides confidential pregnancy testing and assistance with initiation of medical care. The average number of clients served by the Moultrie County Health Department per month are as follows:

## Family Case Management (FCM) Program

The Moultrie County Health Department FCM program operates in conjunction with the WIC program to identify and meet additional needs of families with pregnant women, infants and children. The FCM program assists families in identifying and addressing medical, financial, and social needs and services. The average number of families, as identified by primary qualifier, served by the Moultrie County Health Department per month are as follows:

## Immunization Program

The Moultrie County Health Department provides all required immunizations to children through the age of 18 years as required by the Illinois Department of Public Health and the CDC. The Moultrie County Health Department also provides adult vaccines, including Influenza and Pneumonia Vaccines. Immunization clinics are offered at the Moultrie County Health Department three times per month. Individual appointments may be made in the event that a client cannot be accommodated during routine clinics.

## School Nursing

The Moultrie County Health Department offers a variety of school-based contractual services to public and private schools to ensure compliance with Illinois Department of Public Health and Illinois State Board of Education requirements. These include (but are not limited to) immunization review and report completion, vision and hearing screening and report completion, on-site immunization clinics, head lice checks and other services/assistance as requested and appropriate.

## Get Covered Illinois

Moultrie County Health Department provides information & referrals to individuals needing to access the Get Covered Illinois Program. This service focuses on enrolling individuals in appropriate and affordable health insurance for themselves, their family and small businesses..

## Child Safety Seat Program

The Moultrie County Health Department continues to provide Child Safety Seat Assistance as a service to our county residents. A Certified Child Safety Seat Technician is available to provide education, evaluation, and assistance with proper child safety seat installation and use.

## Lead Screenings

The Moultrie County Health Department provides lead exposure screening and testing to all Moultrie County residents for whom such services are indicated. Assessment of lead risk exposure and testing are available any time at the Moultrie County Health Department. Interpretation of testing results and professional confidential follow-up on lead exposure reduction are provided free of charge to Moultrie County residents.

## Vision and Hearing Testing

Vision and Hearing screening services provided through the Moultrie County Health Department are available to all residents in Moultrie County. Testing is provided at the Moultrie County Health Department as well as at other clinic sites. School-based screening clinics are also provided annually. Interpretation of results and referrals to medical providers are made for clients as appropriate. Moultrie County Health Department staff are certified by the Illinois Department of Public Health in Vision and Hearing Screening.

## Communicable Disease Control

The Moultrie County Health Department works closely with the Illinois Department of Public Health, clients, and their physicians to facilitate reporting, investigation, education, referrals and follow-up for individuals diagnosed or concerned with exposure to a communicable disease. The Moultrie County Health Department also assists schools, area doctors, and other public entities with disease investigation, case contact, and follow-up to prevent the spread of communicable diseases. All services are confidential.

## Adult Health Services

The Moultrie County Health Department Adult Health Services program provides a variety of services to adults in clinic sites throughout Moultrie County. These services include: blood pressure monitoring, cholesterol and glucose screenings, vision and hearing screenings as well as individual education and referral services for a varies health concerns.

## Public Health Emergency Preparedness

The Moultrie County Health Department continues to collaborate with schools, municipalities, medical and emergency response partners throughout the county and state to exercise and develop emergency response plans and systems to meet the needs of Moultrie County residents. In 2017, the MCHD facilitated medical and Long Term Care entities with emergency response planning and preparedness. Over 70 local volunteers are registered with the MCHD and Illinois HELPS as volunteer responders for local and state emergencies.

## Tobacco Free Communities Effort

The Moultrie County Health Department encourages everyone to lead a tobacco-free life and reduce the harmful effects of tobacco, smokeless tobacco and second-hand smoke. The Illinois Tobacco Quitline provides assistance to all individuals with tobacco use cessation. Smoke-Free Illinois was initiated in 2008 by the State of Illinois and requires all public places to be free of second hand smoke inside the building and within 15 feet of all entrances and exits.

## Health Education

The Moultrie County Health Department welcomes the opportunity to educate individuals as well as the public at large on pertinent health topics. ## Vector Surveillance and Control

## Food Service Program

The Moultrie County Health Department provides routine inspections of Moultrie County retail food and food service facilities as required by the Illinois Department of Public Health. Consumer complaints, as well as potential food borne illnesses, are also investigated. Temporary events conducted by non-food service organizations are reviewed to enhance the safety of food served to the public in Moultrie County. The Moultrie County Health Department routinely provides information and updates on food related issues to all food service facilities, and upon request to residents of Moultrie County.

## Water Protection Program

The Moultrie County Health Department, in accordance with Illinois Department of Public Health requirements, provides permits to all persons installing a new water well, repairing or reconstructing an existing well, or sealing an abandoned or unusable well. Provision of permits includes a plan review, inspection, and consumer education as appropriate. The Moultrie County Health Department also provides information on different types of well systems, Illinois Department of Public Health construction and location requirements, safe water supply maintenance, etc. Water testing is also available for well and cistern systems.
